**ADOPTING VARIOUS OPERATING BUDGETS FOR THE CITY OF WILLIAMSPORT INCLUDING THE GENERAL FUND, UTILITY FUND, WBT CAPITAL PROJECTS, CAPITAL PROJECTS FUND, LIQUID FUELS FUND, CITY HALL OPERATING FUND, WBT PLANNING, UNEMPLOYMENT COMPENSATION FUND, DEBT SERVICE FUND, TRADE AND TRANSIT CENTER, ACT 13 FUND, AND POOL REPAIRS CAPITAL FUND**
