WHEREAS, being that Police Officer candidate **Jaime DeSanto** has completed all requirements set forth by the Williamsport Bureau of Police, and her employment with the City of Williamsport will commence on Monday, February 21st, 2022 at the rate of Police Officer A. 




I am respectfully requesting your consideration and confirmation of the following officer candidates for appointment to the Williamsport Bureau of Police:
