SECTION 1: The following Ordinances of Part 1 of the City's Codified Ordinances are amended, as reflected in the attachments hereto:


a. Article 111

SECTION 2: In all other respects, Part 1 of the City's Codified Ordinances remains in force and effect, to the extent not amended hereby.


SECTION 3: EFFECTIVE DATE

**AN ORDINANCE AMENDING PART 6426 OF THE CODIFIED ORDINANCES OF THE
CITY OF WILLIAMSPORT**

Article 111. Council

Amend and add language as follows:

111.01 Composition Meetings and Proceedings

(C) Meetings of Council

(1) Regular Meetings of Council shall be held very other Thursday throughout the year and shall begin at 7:00 PM prevailing time unless otherwise noted. All meetings shall be held in City Council Chambers/Trade & Transit II, and/or remote. Meetings may occasionally be held at other locations with the approval of the majority of Council. As with all meetings, they must be properly advertised. The meetings may be scheduled for the coming year by resolution and then properly advertised. Meetings may be held telephonically and/or digitally during circumstances such as a state of emergency or adverse weather conditions at the discretion of the President of Council, or in his/her absence the Vice President of council. Special meetings may be called by the President of Council, or in his/her absence by the Vice President of Council, or as otherwise provided by law. The notice shall specify whether it is for general or special business. If called for special business, no other business shall be considered unless so stated. Each member shall have notice of special meetings as required by law. At all meetings, a quorum of City Council must be present, either in person or remotely to legally transact business. A quorum of is a majority of City Council members.

111.02 PROCEDURAL RULES AND REGULATIONS

(c) Rule 3. Voting, All votes shall be by roll call vote with the exception of adjournment of the meeting, which shall be by voice vote. A member must be present or attending remotely to participate and vote, provided that both the present members and the remote members are able to communicate with each other.

(h) Rule 6B Limited Courtesy of the Floor

(4) Any person desiring to address council during this period shall notify the City Clerk by 3:00 PM of the day of the council meeting or sign up at the meeting before the stated time that the meeting is to commence.
