#### AN ORDINANCE AMENDING ARTICLE 195 BLIGHTED PROPERTY REVIEW COMMITTEE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WILLIAMSPORT THAT ARTICLE 195 SHALL BE AMENDED BY REVISING THE FOLLOWING SECTIONS:

Section 195.03: Membership, appointment, term and regulations.

- (a) The Mayor is hereby authorized to create and appoint members of the Blighted Property Review Committee, which such appointments shall be approved by Council. Such committee shall be composed of seven members and include the following:
- (1) One member of Council;
  - (2) One member of the Williamsport Planning Commission;
  - (3) One member of the City Redevelopment Authority;
  - (4) One representative of the executive branch of the City; and
  - (5) Three Citizens at large
- (b) Members of the Committee shall serve the following terms:
1. A member of City Council appointed each year at the reorganization meeting
  2. (1) Member of the Planning Commission per their term determined on the planning commission.
  3. (1) Member of the Redevelopment Authority per their term determined on the Redevelopment Authority
  4. The Codes Administrator per term of employment
  5. (3) citizens at large for a three year term

So that the terms of the citizens at large shall continue to be staggered, the initial appointments of the citizens at large shall be as follows;

- (1) One for one year;
- (2) One for two years; and
- (3) One for three years.


#### 901.20 PUBLICATION
