### AN ORDINANCE AMENDING ARTICLE 1727 INTERNATIONAL PLUMBING CODE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WILLIAMSPORT  
THAT ARTICLE 1727 BE ADMENDED AS FOLLOWS:

**Section 1727.04 titled International Plumbing Code** shall be removed and all other ordinances or parts of laws in conflict herewith are hereby repealed.

Article 1727 International Plumbing Code shall be renamed **Plumber's Board of Examiners**.

If any section, subsection, sentence, clause or phrase of this legislation is, for any reason, held to be unconstitutional, such decision shall not affect the validity of the remaining portions of this ordinance. The City of Williamsport hereby declares that it would have passed this law, and each section, subsection, clause or phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses and phrases be declared unconstitutional.

That nothing in this legislation hereby adopted shall be construed to affect any suit or proceeding impending in any court, or any rights acquired, or liability incurred, or any cause or causes of action acquired or existing, under any act of this law; nor shall any just or legal right or remedy of any character be lost, impaired or affected by this legislation.

The **City Clerk** is hereby ordered and directed to cause this legislation to be published.
