### AN ORDINANCE AMENDING THE CODIFIED ORDINANCES OF WILLIAMSPORT PART SEVENTEEN – BUILDING AND HOUSING

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WILLIAMSPORT  
THAT PART SEVENTEEN – BUILDING AND HOUSING BE ADMENDED AS  
FOLLOWS:

**Title 1 – Technical Codes:**

Article 1711 Uniform Construction Code shall now be Article 1700 Uniform Construction Code.

Article 1741 International Property Maintenance Code shall now be Article 1713 International Property Maintenance Code.

**Title 2 – Local Provisions:**

Article 1705 Demolition shall now be Article 1733 Demolition

If any section, subsection, sentence, clause or phrase of this legislation is, for any reason, held to be unconstitutional, such decision shall not affect the validity of the remaining portions of this ordinance. The City of Williamsport hereby declares that it would have passed this law, and each section, subsection, clause or phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses and phrases be declared unconstitutional.

That nothing in this legislation hereby adopted shall be construed to affect any suit or proceeding impending in any court, or any rights acquired, or liability incurred, or any cause or causes of action acquired or existing, under any act of this law; nor shall any just or legal right or remedy of any character be lost, impaired or affected by this legislation.
