



Re: Certified Local Government Program - Continuing Education Scholarship Opportunity

The Pennsylvania State Historic Preservation Office (SHPO) is offering Scholarships to Certified Local Governments (CLG) for the *National Alliance of Preservation Commissions' FORUM 2020~At Home*, held August 3-9. The FORUM is on-line this year, and will offer over 20 live educational sessions on a variety of preservation topics. Sessions will also be recorded for later viewing by participants.

The City is a CLG. HARB members are required, under the CLG program, to have at least 4 hours of training per year. Participation in this Forum will meet the 2020 training requirement. The Scholarship offer is also open to codes staff, planning commission members, and elected officials if anyone wants to be added to the application.

The per person registration cost for FORUM is \$100. SHPO scholarship funds will reimburse the City for the full cost of registration. At this time, I have six people that have committed to attend. The Scholarship awards are made to the City. The City is responsible for registering and paying for the individual attendees. SHPO will make reimbursement payment to the City.

Registration will be contingent upon approval of Scholarship funding from the SHPO. With your approval, I will submit a Scholarship request form. The CLG Master Contract is required as part of the Scholarship application.

ROLLING DEADLINE UNTIL JULY 30, 2020

The Pennsylvania State Historic Preservation Office (PA SHPO) is offering up to \$15,000 in scholarships to CLGs in Pennsylvania to participate in the National Alliance of Preservation Commissions' FORUM 2020 ~ At Home, August 3-9, 2020.

- ✓ FORUM 2020 ~ At Home will offer more than 20 online educational sessions on a variety of topics that will help HARB and Historical Commission members, municipal planning and codes staff, planning commission members, and elected officials better serve their communities.
- ✓ HARB/Commission members and support staff in CLGs are required to receive 4 hours of training each year. Participation in FORUM 2020 will meet the CLG Continuing Education and Training requirements for individuals in your community.
- ✓ Sessions will be offered daily throughout the week of August 3-9 and will also be recorded for later viewing.

REGISTRATION SCHOLARSHIPS

- ✓ The per person registration cost for FORUM 2020 is \$100. The PA SHPO scholarship funds can be used to reimburse the municipality the full cost of registration for individuals from the community.
- ✓ You may request scholarships for as many people as your community reasonably expects to participate during the live programs or to access the recorded sessions. The PA SHPO will make every effort to provide funding for as many individuals as possible.
- ✓ The scholarship awards will be made to the municipality, who is responsible for registering and paying for the individual attendees or reimbursing the individuals if they register and pay individually. The PA SHPO can only make reimbursement payments to the local government, not individuals.
- ✓ Awards will be made on a first-come, first-served basis.

REIMBURSEMENT PROCESS

- ✓ Following the conclusion of the conference, recipients will submit completed reimbursement requests to the PA SHPO, who will issue payment to the municipality.
- ✓ Municipalities must sign and return a Master Grant Contract in order to be reimbursed.
