### AN ORDINANCE

6375

**AN ORDINANCE AMENDING ARTICLE 902 OF THE CITY'S CODIFIED ORDINANCES RELATING TO BRICK PAVED STREETS AND REMOVING CERTAIN STREETS FROM THOSE TO BE PRESERVED UNDER THE ORDINANCE**

**BE IT HEREBY ORDAINED BY THE CITY COUNCIL OF THE CITY OF WILLIAMSPORT THAT ARTICLE 902 OF THE CODIFIED ORDINANCES OF THE CITY OF WILLIAMSPORT BE AMENDED AS FOLLOWS:**

**SECTION 1:** The following streets will be removed from Section 902.01, Table D, as streets that need to be preserved:

- Dubois Street between Hepburn Street and Laurel Street
- Neece Street between West Edwin Street and West Fourth Street

The location of the previously vacated Court Street should be corrected to reflect the following:

- Court Street between Sixth Street and a point 50 feet south of southern Right-of-Way line of Dubois Street

**SECTION 2:** All other portions of Article 902 not inconsistent herewith will remain in place.

**SECTION 3:** This ordinance shall become effective 20 days after final reading.




