WHEREAS, the City desires to openly solicit requests for proposals for professional services; and




- Delta Development Group – Government Relations (Resolution #8787, approved 07/05/18)

BE IT FUTHER RESOLVED that the Mayor and City Controller are authorized to execute any documents necessary to effectuate the intent of this Resolution.

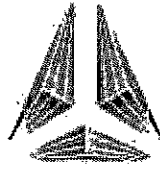

This Letter of Agreement serves to amend the above referenced Agreement dated as of June 1, 2018 by and between Delta Development Group, Inc. (Delta) and River Valley Transit (RVT).

This Letter of Agreement modifies the Compensation as specified in Section 4 of the Original Agreement. Delta shall bill the client on an hourly basis per the rate table below. The monthly not to exceed amount shall be Seventeen Thousand Five Hundred Dollars (\$17,500.00), plus reasonable and ordinary expenses.

This Letter of Agreement will remain in effect until written termination by either party as subject to the Termination Clause in paragraph 11 (30 Days) of the Original Agreement.

All other provisions of the Original Agreement will remain the same.
